## "Salad and Go Survey" Sweepstakes OFFICIAL RULES

Two (2) methods of entry are as follows:

- 1. Entrants who receive a guest feedback survey invitation (through in-store purchase, or email) from the Sponsor must follow the instructions to complete the Guest Feedback Survey to be entered into the Sweepstakes. Each completed survey will generate one (1) Sweepstakes entry. All online entries must be received by 11:59:59 p.m. EDT on November 30, 2024. Online entries must be received by 11:59:59 p.m. ET on the last day of each Entry Period in order to be eligible for the drawing in question.
- 2. impaired or incapable of running as planned for any reason, including but not limited to (i) infection by computer virus or bugs, (ii) tampering or unauthorized intervention, (iii) fraud, (iv) technical failures, or (v) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the applicable Prizes (defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. **DRAWING AND NOTIFICATION:** All potential Prize Winners will be selected in two (2) random drawings from among all eligible entries received by the Administrator whose decisions are final and binding. By accepting a Prize, the Prize Winners agree to release and hold harmless the Released Parties from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of the Prize. Each Prize Winner must sign and return to the Administrator an Affidavit of Eligibility, Liability & Publicity Release in order to claim his/her Prize within seven (7) days in order to claim his/her Prize. The headings herein are for convenience only, do not constitute a part of these Official Rules, and shall not be deemed to limit or affect any of the provisions hereof. The waiver by Sponsor or Administrator of any provision of these Official Rules shall not constitute a waiver of any other provision herein. The rights and obligations hereunder may not be assigned by Entrants, whether by operation of law or otherwise, without the prior written consent of Sponsor, and any attempted assignment in violation of the foregoing shall be null and void. These Official Rules shall be binding upon, and inure to the benefit of, the permitted successors and assigns of Sponsor, Administrator, and Entrant.
